

CRIMINAL LIABILITY OF CHILDREN IN ONLINE GAMBLING PROMOTION AND THE RESTORATIVE APPROACH

However, a criminal law approach that prioritizes repressive sanctions without considering rehabilitative aspects risks damaging children's futures and exacerbating social problems. This study examines the effectiveness of the juvenile justice system in Indonesia in handling online gambling promotion cases. It assesses the urgency of implementing a restorative approach as a fairer and more recovery-oriented alternative. The restorative approach emphasizes the restoration of relationships between perpetrators, victims, and the community so as to avoid stigmatization and provide opportunities for children to improve their behavior. The results of this study emphasize that the legal system must prioritize the principle of rehabilitation rather than punishment alone in order to ensure child protection while preventing the recurrence of criminal acts. Thus, the application of restorative justice in cases of children involved in online gambling promotion is a strategic step to create a more humane and future-oriented justice system.

This poses a threat to children's psychological and social development and raises complex legal challenges related to the criminal liability of children in cases of online gambling promotions.

In the Indonesian criminal law system, the existence of children as perpetrators of criminal acts requires a different approach compared to adults. On the one hand, criminal law requires accountability for criminal acts committed. However, on the other hand, children often do not have sufficient cognitive and emotional capacity to understand the consequences of their actions. Therefore, the application of retributive punishment to children is often ineffective in achieving rehabilitation goals and can worsen their psychological and social conditions.

The restorative approach has been put forward as a more humane alternative in dealing with children involved in criminal acts, including online gambling promotion. Restorative justice focuses on efforts to restore the impacts caused by the crime and involves the active role of the perpetrator, victim, and community in the resolution process. With this approach, children involved in online gambling promotion are expected to be given the opportunity to improve their behavior without having to face punishment that could potentially damage their future.

Meanwhile, social engineering theory can be used to understand the social and psychological factors that influence children's involvement in online gambling promotion and as a basis for designing more effective legal policies. Based on these regulations, children who act as online gambling promoters can be categorized as perpetrators of criminal acts. Although there are criminal regulations that can be applied, the SPPA Law provides special protection for children who conflict with the law.

Based on Article 1 number 6 of the SPPA Law, diversion is the transfer of the settlement of juvenile cases from the criminal justice process to a process outside the criminal justice system, such as coaching and rehabilitation. This approach aims to protect children from the negative impacts of the conventional criminal justice system and ensure that they get a second chance to improve themselves. From a legal perspective, children involved in online gambling promotions can be subject to criminal responsibility. However, in accordance with the principles in the SPPA Law, the approach used towards children in conflict with the law must be more oriented towards protection and rehabilitation than retributive punishment. The diversion mechanism allows children to avoid severe criminal penalties and undergo a more educational coaching process. - 4) Multi-Party Collaboration: The role of the government, private sector, communities, and non-governmental organizations (NGOs) is essential in creating a support system that can help rehabilitated children get better employment or education opportunities.
- 5) Strengthening Law Enforcement against Key Actors: While children involved in online gambling promotion should be rehabilitated, the main perpetrators behind the online gambling network need to receive stricter legal action so that they do not continue to exploit children in this illegal activity.

CONCLUSION

The involvement of children in online gambling promotion is a complex issue that requires a comprehensive legal and social approach. Although Indonesian criminal law has regulated the prohibition of gambling and the distribution of its content, children involved must receive special treatment as regulated in the SPPA Law, with a focus on rehabilitation and social reintegration. The social engineering approach is an effective strategy for preventing and handling this case. Through education, stricter regulations, and community-based interventions, children can be given a better understanding of the dangers of online gambling and get more positive alternatives. The role of parents, schools, government, and digital platforms is also very important in creating a safer digital ecosystem for children.

From a policy perspective, a rehabilitation and diversion-based approach should be prioritized to ensure that children are not only protected from retributive punishment that is
